1. Call to Order

Chairperson, Josh, calls the meeting to order at 7:02 PM AST.

1.1. Roll Call

Chairperson, Josh, performs roll call.

2. Approval of Agenda

Motion: Be it resolved that the Agenda for September 25th, 2022 is approved.

Mover: Chair Assumed

Secunder: Kordell

Notes: Amendments suggested to the Agenda include: removal of item 6.3 Report to Council from VP Events & Services, Amanda, as she has sent her regrets, as well as to add a discussion on the interim student senators, as it is being brought back to the floor (added on as item 5.12 of the agenda).

The vote passes unanimously. Motion carries.

3. Chair's Remarks

3.1. Territorial Acknowledgement

Chair - I just want to acknowledge that UNB stands on the unsundered and unceded ancestral homelands of the Wolastoqey peoples.

3.2. General Remarks

- Masks - needed while walking into the SUB, but once you're in here, you are able to remove them
- Check-ins - I am always available to chat or meet with anyone in regard to anything to do with the council, their positions, or just to chat. In all of my emails, I provide my alternate email address and phone number and am available really any time and any day. In a way to make myself more available to you all, I will have some sort of "Office Hours" Monday, Wednesday, and Friday between 1 and 4 PM. I will most likely be just working out of the HIL or SUB but if you just shoot me a message I can verify that information. As for specific councillor check-ins on my part, I will be reaching out to all councillors over the span of the year to provide check-ins. Whether it's just general how are things going, or checking in on your projects, sitting in on a meeting, etc, I will reach out to you all periodically.
- By-Laws - This is not directed at anyone, but I just know it was very briefly talked about in transition so I would like to expand some more on it. I would like to remind you all of the attendance policies, with your positions you are supposed to be here every session, and if you miss 3 sessions it opens the potential for a vote to remove. Of course, things pop up, whether its plans, appointments, physical or mental health, or really any other reason, and by all means you do not have to let me know the reason that you are not attending but please just send me your regrets either through email or text preferably 24-48 hours before, but of course, I fully understand if things happen last minute.
- Formatting - Thanks for putting up with me but just one last thing to cover is a change of procedure in which I will be chairing the meetings. From now on, I will not be including "Question Period" in our agendas. Instead, aside from debate and discussion with any items that include a motion; any item that is solely discussion such as the "Reports to Council" from the executives, my general remarks as chair, and presentations such as what Mia Scalabrino has, a question period immediately after. I ask that once the individual has concluded their presentation, I will address the council thanking the presenter for their time, and will ask the council if there are any questions. If there are, any questions, I ask that you raise your placard which I will then recognize the question which you may ask. Once the question is asked, the presenter is able to respond without my discretion. Once there are no more questions, we will move on with the agenda.

4. Approval of Previous Minutes

Motion: Be it resolved that the minutes from September 18th, 2022 be approved.

Mover: Chair Assumed

Notes: Amendment to fix the spelling of Ridhi's name.

The vote passes unanimously. Motion carries.

5. Substantive Business

5.1. Presentation from Mia Scalabrino, 2021/2022 Accessibility Councillors

Motion: Be it resolved that Mia Scalabrino is awarded to speak on the floor as voted upon by Council with an additional 5 minutes added to the standard speaking rights.

Mover: Kordell

Secunder: Kianna

Notes: Mia reached out, asking to give a presentation to the council regarding the role of the accessibility councilor and its scope in relation to the clubs and societies on campus. Given that speaking is restricted to councilors, approval by the council is needed to allow Mia to provide a presentation (with allowance for a 10-minute period).

The vote passes unanimously. Motion carries.

Mia: Asking for a student union accessibility counselor to come from the All Abilities club and an executive in the All Abilities club to act as a liaison to the UNBSU and the All Abilities Club. Looking for advice on how to run elections should this suggestion be taken.

Kordell - Last year we had an issue/confusion with the business association as they have a similar Accessibility position on BAUS. We would need to see how this works with Baus. We would also need to see justification as to why specifically the councilor would come from the All Abilities Club. For example, we have S.P.R.I.N.G.. Does it tie the councilor too restrictively to All Abilities Club where they could work with any club in the accessibility realm?

Motion: Be it resolved that exploring this opportunity further be referred to the Policy Committee.

Notes: No discussion

The vote passes unanimously. Motion carries.

Mia - I also sent a survey to Kordell. Can the UNBSU post this? I will also quickly review the survey. It's 17 questions, we started working on it last semester and would like to get it out as soon as possible. We can still make edits though, if you have any suggestions.

Abby - Has the survey had any REB reviews? It's important to do that with this kind of information so that we don't infringe upon any ethical research rights.

Mia - No, we haven't. How would I go about doing this?

Kordell - I will send the information.

Jill - When you start to receive responses in regards to the classroom experience, maybe we can sit down to discuss the responses you are getting.

5.2. Presentation of Signing Authorities

Motion: Be it resolved that Council grants Karen Miner, Terry Noble, Isabella Hallihan, and Kordell Walsh signing authorities for the UNBSU Council of 2022-2023.

Mover: Kordell

Secunder: Jill

Notes: Presenting the names of individuals we have granted signing authority of the union. This is just following the procedure, as it is outlined in the bylaws. It makes sense to have multiple signing authorities so that if folks are out of office, business can proceed. It has been tradition to have these four individuals associated with signing authority. No further discussion.

The vote passes unanimously. Abstention from Isabella and Kordell as they are 2 of the representatives being granted signing authority. Motion carries.

5.3. Policy #1: Foreign Credential Recognition

Motion: Be it resolved that the Foreign Credential Recognition be ratified as an official Union policy as presented/amended.

Mover: Kordell

Secunder: Zach

Notes: The VP Research & Policy attended CASA conferences across the country, networked with students, and looked at primary and secondary research to get these policy asks. It follows a PCR model where it follows the principles of the union, the provided statistics, and provides recommendations. Any questions to be directed to VP Research & Policy. No further discussion.

The vote passes unanimously. Motion carries.

5.4. Policy #2: Mental Health

Motion: Be it resolved that the Mental Health Policy be ratified as an official Union policy as presented/amended.

Mover: Kordell

Secunder: Shayna

Notes: Same as Policy #1. Spoke with a lot of folks within counseling services, Horizon Health officials, and the data in New Brunswick as of right now. No further discussion.

The vote passes unanimously. Motion carries.

5.5. Policy #3: Affordable Housing

Motion: Be it resolved that the Affordable Housing Policy be ratified as an official Union policy as presented/amended.

Mover: Jill

Secunder: Ridhi

Notes: Same as in Policy #1 and #2. Spoke with the tenant's rights association of NB, government stakeholders, and conducted research.

Kordell - As an aside, Rose has put a ton of effort into these policies, so a huge shout out to Rose for making these all happen.

No further discussion.

The vote passes unanimously. Motion carries.

5.6. Part-Time Student Senator Discussion

Jill - This isn't a super big topic to touch on, we are hopefully going to see it go forward to the Policy Committee to discuss further. We touched on it last week in the presentation, where we absorbed ALPS (which no longer exists since we represent all part-time and full-time students). There is a part-time student senator position that exists but that we haven't been able to use. We (nominating committee) are putting forth a proposal to Senate, and hopefully, they will approve it. We met with Sarah to discuss it, and election regulations will have to be looked at.

Kordell - For historical context, one of the reasons we absorbed ALPS, is that for probably 6 or 7 years, they struggled to fill their executive positions and their senate positions. One of the things we've seen since then, is that we haven't had an individual put forward their name for councilor or senate at the UNBSU. We've been looking at increasing the likelihood that this position becomes appointed. We'd like to make sure that this isn't a piece of information that people forget about. Part-time students, although the UNBSU represents them, need representation.

Motion: Be it resolved that the Council refer a general review of the Part-Time Student Senator position to Policy Committee for further consideration.

Mover: Jill

Secunder: Kate

Notes: No further discussion.

The vote passes unanimously. Motion carries.

5.7. Appointment of Councillor to Orientation Hiring Committee

Motion: Be it resolved that Sangeet be appointed as a Councillor to the Orientation Hiring Committee for the 2022/2023 year.

Mover: Chair Assumes

Secunder: Shayna

Notes: Secret Ballot Results In favour of Sangeet to be brought forward for the appointment to the hiring committee.

Motion carries. Sangeet appointed to Orientation Hiring Committee.

Orientation has its own set of bylaws and policies. They outline the hiring committee that oversees orientation has a councilor representative on it to appoint Chair and Vice Chair. The deadline we are supposed to meet is the end of November. We begin hiring black shirts in January, and March for red shirts. We need someone from

council to sit on this committee. Questions can be forwarded to Sangeet. Both Sangeet and Emily are interested in the position.

Kordell- My recommendation would be to allow Sangeet and Emily to explain why they're interested in the appointment, and then run a secret ballot election where folks will send their ballot to the chairperson.

Chair - Okay, we will proceed in this way.

Sangeet- The reason I would like to be appointed is because I was on the committee last year, and have been a red shirt. I have first-hand experience with orientation and have spoken with lots of black and red shirts to see how it was for them. I have also been in contact with the previous Chair and Vice Chair. So, I sort of know what to expect, and different types of answers that are appropriate for the hiring. I hope to use this experience to hire individuals for the Vice Chair and Chair hire.

No questions for Sangeet.

Emily - I have a similar experience to Sangeet. I have been on both a black shirt and a red shirt. It is an awesome opportunity to give back to the school. Being on the selection committee would help put forth an awesome orientation. On a personal development side, it would be nice to see the other side to oversee that we get a Vice Chair and Chair that best fit.

No questions for Emily.

5.8. Appointment of Councillors to Code of Conduct Committee

Jill - We need to have two councillors appointed to the Code of Conduct Committee, in the event that it needs to be used. We're hoping for two councillors to put themselves forward, and then we'll ratify them in the position. Could anyone interested please raise your placards?

Nominees: Amy and Shayna

Kordell - Just a quick note: the composition of the committee will change depending on who the complaint is levied against. It helps ensure we are creating a safe environment for all in the SU.

Motion: Be it resolved that Shayna and Amy be appointed as Councillors to the Code of Conduct Committee for the 2022/2023 year.

Mover: Chair Assumed

Seconder: Kianna

Notes: No further discussion.

The vote passes unanimously. Motion carries.

5.9. Swearing in of Chief Appeals Officer

Chair - At this point, I need to relinquish my spot as chair to be sworn in as the Chief Appeals Officer to avoid conflict of interest. The bylaws state that in this instance, the CRO will take over for me. I am also going to motion for a 5-minute recess to allow for the CRO to get ready.

Motion: Be it resolved that the Council will suspend for a 5-minute recess.

Mover: Chair Assumed

Secunder: Kordell

Notes: No discussion.

The vote passes unanimously. Motion carries.

CRO - I am calling the meeting back to order at 8:05 PM AST.

Josh - According the bylaws number 3, I have to be sworn in using this oath.

Josh - I, Joshua Lohnes, do swear (or solemnly affirm) that I will faithfully, truly, and impartially, to the best of my skill and knowledge, fulfill and perform my duties as Chief Appeals Officer of the University of New Brunswick Student Union, Inc.

5.10. Appointment of Associate Appeals Officer

5.10.1. Appointment of Associate Appeals Officer #1 to the Appeals Board

Chair - As per bylaws, I have to bring forth nominees before October 10th, 2022. I held interviews and underwent the screening process over the last week to find two Associate Appeals Officers. Originally, I reached out to the Faculty of Law as members have to originate from Law. There was a mass email sent out to the faculty, and I looked on LinkedIn. We had about 17 candidates in total, of which 6 were ineligible due to association with ratified clubs and societies. Eventually, possible candidates were screened down to 10 and those 10 were interviewed. I took into consideration resumes and the interview and ranked them based on qualifications. Abby Companion is a wonderful recommendation with experience within the Faculty of Law as a research assistant, and as a legal assistant. I believe with the combined experience from the role last year, and legal experience, Abby proves to be a suitable candidate.

Motion: Be it resolved that Abby Companion be appointed as an Associate Appeals Officer at the recommendation of the Chief Appeals Officer for the 2022/2023 year.

Mover: Chair Assumed

Secunder: Sangeet

Notes: No further discussion.

The vote passes unanimously. Motion carries.

5.10.2. Appointment of Associate Appeals Officer #2 to the Appeals Board

Chair - As said above in item 5.10.1, I followed the exact same process to find a second Associate Appeals Officer. The second candidate is Destiny Grant. Her experience mostly consists of various legal experiences making her a suitable candidate. She also has experience with appeals.

Motion: Be it resolved that Destiny Grant be appointed as an Associate Appeals Officer at the recommendation of the Chief Appeals Officer for the 2022/2023 year.

Mover: Josh

Seconder: Zach

Notes: No discussion.

The vote passes unanimously. Motion carries.

5.10.3. Swearing in of Associate Appeals Officer

Chair - Similarly to me, the Associate Appeals Officers have to be sworn in and complete the oath. Given that only councilors are awarded speaking time, I will relinquish my time as chair to each of the Associate Appeals Officers for them to complete the oath.

Abby Companion - I, Abby Companion, do swear (or solemnly affirm) that I will faithfully, truly, and impartially, to the best of my skill and knowledge, fulfill and perform my duties as Associate Appeals Officer of the University of New Brunswick Student Union, Inc.

Destiny Grant - I, Destiny Grant, do swear (or solemnly affirm) that I will faithfully, truly, and impartially, to the best of my skill and knowledge, fulfill and perform my duties as Associate Appeals Officer of the University of New Brunswick Student Union, Inc.

CRO relinquishes the chair back to Josh.

Chair - Thank you. I will now reclaim my time as Chair.

5.11. Faculty Councilor Updates

Warren - Not too much to report. Met with the Law Student Society President, regarding the lack of communication between the UNBSU and the Law Student Society. Ironed out the communication, owing to transition periods between councils, etc. Otherwise, discussed the main issue facing the Law Faculty right now, which is course registration. The Law Faculty uses a different course registration system than other students and tried to transition to a new system over the summer and it caused a lot of stress for students. We are looking to lobby the administration to fix the issue.

Rayleh - No reports to council.

Emily - No reports to council.

Kerri - No reports to council.

Shayna - Attended the arts faculty council meeting as undergrad representative. Rose gave lots of information about it, and I agreed to sit on it. Attended the welcome reception for arts faculty members to meet with deans and the arts faculty and administration. I reached out to Tabitha Armstrong to send out a blurb about myself to give information on me and my role with the SU. I also set up a meeting with Tabitha and Dr. McNutt to discuss my role and potential relationships. We haven't had a representative here for a few years, so it's nice to be engaged again.

5.12. Discussion on Interim Student Senators

Kordell - Following up on last week's conversation, we have 6 or 7 student senator positions. Only 3 of them are currently filled. It is always nice to have as much representation in the senate as possible, so the hope is that councilors will put forth their name to sit at the October and potentially November senate meetings depending on the ratification of election results.

Jill - I know I posted to Facebook last week after last week's meeting. It isn't a huge commitment as there is potentially two, maybe only one meeting. Pre-senate meetings would be held with me and the other students. It would be a good opportunity to lobby to administration.

Kordell - How long are a pre-senate meeting and a senate meeting?

Jill - Pre-senate meeting packages the last meeting was only around 90 pages long, and usually the whole meeting revolves around that package. You kind of know where the conversation goes. The pre-senate meeting is usually around 1 hour. The senate meeting is usually around 2 hours. It happens in Tilley Hall, and both are happening in person.

Rayleh - What times for October and November?

Jill - October 11th at 4 PM and November 22nd at 4 PM.

Rayleh - If I sign up for it, is the obligation for the November tentative?

Jill - We will definitely need you for October, but please try to be available for November as well if necessary.

Kordell - The only thing is, with election results, if there was an appeal that went through, the timeline for the investigation and hearing and decision could overlap the councilor being ratified by that November 22nd date. If someone broke the bylaw, don't submit it after the deadline to be ratified. Generally, not an issue, but it would be nice to have folks available just to be safe.

Jill - We need about 3, just to have all spots filled.

Tasneem - Am I eligible?

Jill - I think so.

Rayleh - I can do October, not November.

Amy - I can do November, not October.

Jill - I will inquire to Sarah about Tasneem. I know Kordell would be looking to take one of the spots if we can get that approved tonight.

Motion: Be it resolved that Kordell is appointed to the Interim Student Senator position for the 2022/2023 year.

Mover: Jill

Secunder: Rayleh

Notes: No discussion.

The vote passes unanimously. Motion carries.


